Services Provided: Kennel Free Boarding

Signatures: Signatures are required by the main contact person and their spouse or partner.

Method of Payment: Payment is due in advance for stays of 7 days or less. 50% in advance for stays longer than 20 days with balance due at the end of Pet's stay. We accept cash and personal checks.

Please Bring Your Dog's Food & Treats: It is best that they remain on their own food so as not to upset their digestive track. Treats are given to all the dogs unless your dog has a special diet.

Client Requirements before your pet/s may stay here:

- Completed Owner/Pet Information and Contract
- Copy of Shot Records or Health Certificate from your Vet
- Negative Fecal Report within the last 6 months
- Collar with ID Name Tag

Owners understand that supervised off-leash play and interaction between other dogs is encouraged. Owners also acknowledge that dogs are unpredictable in behavior and are aware of the risks involved in such play and assume all risks.

Dog Run Lodge Liability Release

You have enrolled in the Boarding service program offered by Dog Run Lodge.

I acknowledge that dogs are unpredictable in behavior and I understand that injuries to my pet, myself and my guests might reasonably be foreseen to result from my dog's participation with Dog Run Lodge. I am fully aware the Dog Run Lodge encourages off-leash play and interaction of dogs in its care and accordingly I assume any and all risks related to Dog performance of services by Dog Run Lodge, including but not limited to bites, bodily injury, damages, claims and expenses that may occur as a result of my dog's actions.

1. In the absence of gross negligence, Dog Run Lodge or the company's instructors, officers, directors, agents or employees shall not be liable for any illnesses and/ or injury suffered by the client's animal/s, including animal bites and complications thereof, and including injuries caused by other Dog Run Lodges clients' Dogs, Dog Run Lodges and its instructors, officers, directors, agents, or employees, which injuries are suffered or caused to be suffered while under the care of this service contract.
2. To hold harmless and indemnify Dog Run Lodge and its instructors, officers, directors, agents, or employees for any claim arising from the conduct of your dog(s) while under the care of this service contract.
3. In the absence of gross negligence, Dog Run Lodge or the company's instructors, officers, directors, agents or employees shall not be liable for loss or damage from disease, transferring of parasites from one animal to another animal, death, running away, theft, fire, injury to persons, other dogs, or property by said animal, or other causes.
4. Authorize Dog Run Lodge or the company's instructors, officers, directors, agents or employees to take the client's pet/s in their vehicle for transportation, for joy riding, to the park or hiking, and any emergency situations. In the absence of gross negligence, Dog Run Lodge or the company's instructors, officers, directors, agents or employees shall not be liable for loss or damage that may occur when client's dog is traveling in a vehicle.
5. Occasionally, photographs or video footage may be taken of animals that are staying or being exercised with Dog Run Lodge. We give Dog Run Lodge our permission for any resulting photographs or video of our animals to be used for advertising or educational material, understanding that the resulting photographs or videos are the sole property of Dog Run Lodge.
6. Any legal expenses incurred in defense or enforcement of this contract shall be the total responsibility of the owner of the animal.
7. I hereby acknowledge that I have read all of the above and agree as owner or agent of the owner to the forgoing. I also understand and agree that all outstanding charges are due & payable upon completion of services.
